1. Title of the practice:

‘Limitless learning: An Exhibition based practice teaching lesson’

The context –

Exhibition is a very interesting approach in teaching-learning. Exhibition gives great opportunity to create creativity and activeness among the students, but when teacher

takes their students for exhibition rarely seen objectives are filled. Generally teachers are active on home ground (school) and miss out creative and interesting platform of learning. Here we are talking about how to acquaint teachers on exhibition based teaching learning process so they really hit the learning opportunities of exhibits. There is limitless knowledge associated with an exhibit, and to find out more and more opportunities for such learning ground practice and awareness to be given to pupil teachers. Putting exhibition and making exhibit models engage them in intense reading and creative presentation.

Objectives of the practice:-

Student teachers will able to

- Do intense reading on topic for exhibition.
- Plan their exhibit as per level of their customer (school students).
- Search varied resources to get exhibits.
- Prepare exhibits as per actual requirement.
- Organize exhibition in school.
- Give exhibition based learning opportunity to school students.
- Gain confidence on exhibition based teaching learning process.

The Practice:-

- To present either in group of 2 or individually. To select topic pupil teacher discussed among the group, guiding professors and with school teacher on line like
 - Necessity of theme/ topic,
 - Level of the school students,
 - Place of exhibition in school etc.
- Reading: it was expected form pupil teacher to read varied recourses on the selected theme/topic
- Planning for exhibition: it was expected form pupil teacher to prepare exhibits based lesson plan and discuss with guiding professor on their plan to get more innovative ideas and accurate strategies.
- Collection and preparation of exhibits: It was expected from pupil teachers to collected required exhibits or prepare or both so to acquainted with ample resources for exhibition.
- Organizing the exhibition: it was expected from pupil teachers to arrange and organize the exhibition on the theme/ topic in allotted room or place of the school
- Presentation of exhibition: It was expected form pupil teacher to take the class students to exhibition with proper planning, so to achieve their objectives for exhibition. They presented their exhibition to peer, in-charge teacher, school teachers for presentation they utilized various strategies like some pupil teacher applied explanation method while some implemented creative questioning.
- Reflection on exhibition: it was expected form pupil teacher to reflect on their exhibition based teaching skill and discuss with their guiding professor on it.

2. Title of the practice:

'Intervention in community issues: Community service based practice teaching lesson'

The context:-

Community service for teens is becoming a course requirement in most schools/ college curriculum. More and more, middle and high school students around the country are being required to perform community service hours as part of their learning experience. Teachers often struggle with how they can guide their students to select a community service project that will be meaningful instead of just having it be something kids mark off their checklist or use to pad their "resume". But if students can get involved in giving back to a cause or helping their community in a way that matters to them, the lasting benefits can be far-reaching. As anyone who has ever volunteered knows, the satisfaction and pride that comes from helping others can be life changing. With objective to give such training and exposure to our pupil teacher which truly sensitizes future teacher over current community issues, and give courage and insight for intervention for this. This is tuning with our mission "To produce teachers with a high purpose and intense pragmatism who will be the change agents in future." This made us to take lead and make a compulsory activity in practice teaching.

Objectives of the practice:-

Student teachers will be able to

- Investigate community issues.
- Plan intervention strategies.
- Make courageous to present their intervention.
- Make community aware on community issues.
- Gain confidence to say community issues in mass.

4. The Practice:-

In earlier B.Ed. syllabus use to get community service opportunity through community work and extension activities, but never get place in core practice teaching practicum. This innovation was introduced with intention to develop managerial skill for community service.

To present community based lesson student followed following step

- Selection of issue: To select issue pupil teacher discussed among the group, guiding professors and near community people on line like
 - Problems of the community.
 - Crucial issues of community needs intervention,
 - Place for community lesson presentation etc.
- Resource gathering and generation: it was expected form pupil teacher to discussion, short survey, reading to get exposure on the resources for the issue.
- Planning for intervention: it was expected form pupil teacher to prepare intervention based lesson plan and discuss with guiding professor on their plan to get more innovative ideas and accurate strategies.
- Organizing and presenting the intervention: it was expected from pupil teachers to arrange and organize and present their intervention on the issues in near vicinity.
- Reflection on exhibition: it was expected form pupil teacher to reflect on their intervention based teaching skill and discuss with their guiding professor.

5. Obstacles faced if any and strategies adopted to overcome them:


